## VALLEY AG SOCIETY TERMS OF ENTRY

Welcome to the Valley Ag Society and the Manitoba Stampede & Exhibition grounds. To ensure the best possible experience for all of our guests, we ask that you conduct yourself according to all applicable laws as well as all of the rules, guidelines and policies of the Valley Ag Society (VAS), including those listed below, and those posted within Manitoba Stampede & Exhibition grounds (collectively, the "Rules").

Your access to or attendance at the Manitoba Stampede Exhibition Grounds is conditional on your acceptance of the Rules.

Thank you for joining us and we hope you enjoy your visit!

### 1) RULES

- a) Tickets, SuperPasses and other entitlements are non-transferable, non-exchangeable, non-refundable, revocable and void if altered. Tickets, SuperPasses, coupons, vouchers, passes and the like that are lost, stolen or fraudulent will not be honoured.
- b) All persons, bags, parcels, clothing and other items may be subject to screening/security checks at Manitoba Stampede & Exhibition grounds entrances and also within the Park.
- c) Guests declining to be searched will not be permitted into Manitoba Stampede & Exhibition grounds.
- d) We reserve the right not to allow any bag, parcel or other items to be brought into Manitoba Stampede & Exhibition grounds, and to deal with any unattended object in such way as we consider appropriate. Non-permitted items should be kept at home, stored in your vehicle, or can be voluntarily surrendered at the entrance. Surrendered items will not be returned.
- e) Please show common courtesy to fellow Manitoba Stampede & Exhibition grounds guests, volunteers and employees by not using profanity or engaging in unsafe, illegal, disruptive or offensive behaviour.
- f) For the comfort of all guests, smoking of tobacco, e-cigarettes or other products that produce a vapour or smoke are allowed only in designated smoking areas. Marijuana (for medical purposes or otherwise) and illegal drugs may NOT be consumed on Manitoba Stampede & Exhibition grounds property.
- g) In keeping with our family-friendly atmosphere, proper attire, including shoes and shirts, must be worn at all times. Clothing with rude, vulgar, offensive language or graphics and images/emblems that can be identified as gang colours are not permitted. These items of clothing must be removed or turned inside-out. If in doing so the results do not meet the VAS's Terms of Entry you may be asked to leave Manitoba Stampede Property.
- h) Bikini/bathing suit tops must be covered up while on Manitoba Stampede & Exhibition grounds. Sheer, mesh and see-through clothing cannot be used as a cover-up over bathing suits.

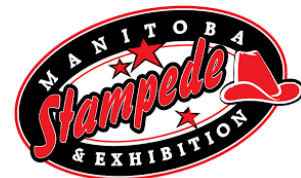
- i) Laws prohibiting consumption of alcoholic beverages by minors, illegal drugs, and disorderly conduct of any kind will be strictly enforced. All guests are encouraged to drink responsibly. Please don't drink and drive.
- j) Access to attractions depends upon the safety rules for each attraction.
- k) Amusement rides will be available at Manitoba Stampede & Exhibition grounds during the Manitoba Stampede. There is an inherent risk in participating in any such rides. We expect our guests who seek to enjoy such rides to:
  - l) Exercise good judgment
  - m) Act in a responsible manner
  - n) Comply with all specific guidelines posted at the entrance of every ride
  - o) Obey all oral and written warnings
  - p) Properly use all ride safety equipment provided

## 2) TERMS OF ENTRY

- a) We endeavor to make your time at Manitoba Stampede & Exhibition grounds as safe and enjoyable as possible. Nevertheless, please be aware that there are risks inherent to your visit. By entering or otherwise attending Manitoba Stampede & Exhibition grounds, you agree that you voluntarily assume all risks and dangers connected to, associated with, or incidental to your presence at Manitoba Stampede & Exhibition grounds.
- b) We may photograph, film, videotape, record or otherwise reproduce the image and/or voice of any person who enters Manitoba Stampede & Exhibition grounds and/or attends VAS produced events and use the same for any purpose without payment to any person.
- c) You consent to be photographed, filmed and/or otherwise recorded in connection with, or as part of, VAS's journalistic, advertising, marketing, promotional, archival and/or security activities;
- d) You consent to such photography, filming and/or recording, including the use of UAV(unmanned aerial vehicle) / drone which may be used to capture footage and will be flown in close proximity on park. And to any use, in any and all media, throughout the world in perpetuity, without compensation to you, of your appearance, voice and/or name for the above-noted purposes;
- e) You understand that all photography, filming and/or recording will be done in reliance on these consents given by you by entering Manitoba Stampede & Exhibition grounds
- f) Our re-entry guidelines are as follows:
  - i) Admission is not guaranteed in the event of a force majeure.
  - ii) You acknowledge and agree that your admission to and attendance at Manitoba Stampede & Exhibition grounds is conditional upon your compliance with all Rules, including for greater certainty, all applicable laws, by-laws and posted facility rules (including these rules and terms of entry).
  - iii) We reserve the right to deny admission or to require a person already admitted to leave Manitoba Stampede & Exhibition grounds, without refund, liability or compensation if we consider that the circumstances so require.

- iv) We may from time to time, without prior notice and without refund, liability or compensation, change the operating hours of Manitoba Stampede & Exhibition grounds or any attraction, close Manitoba Stampede & Exhibition grounds or any part of it temporarily, restrict the number of persons having access to Manitoba Stampede & Exhibition grounds, and/or suspend or cancel any attraction or entertainment program if we consider that the circumstances so require.
- g) Manitoba Stampede & Exhibition grounds 'Rules' and 'Terms of Entry' are subject to change without notice.
- h) Other important legal terms.
- i) You voluntarily assume all risks and dangers connected to, associated with or incidental to your attendance at Manitoba Stampede & Exhibition grounds, including your presence at an event at Manitoba Stampede & Exhibition grounds (an "Event").
- j) Under no circumstances will VAS be responsible for any loss, injury (including personal injury), damages or liability that may arise out of or is any way connected to an Event or your attendance at Manitoba Stampede & Exhibition grounds.
- k) You hereby waive and release all claims or actions against VAS or any of its sponsors, as well as against any of the respective affiliates, directors, officers, employees and volunteers of the VAS or its sponsors, for any loss, injury (including personal injury), damages or liability that may arise out of or is any way connected to an Event or your attendance at Manitoba Stampede & Exhibition grounds, regardless of whether such loss, injury, damages or liability arises from negligence, libel, defamation, loss of privacy, or otherwise.
- l) From time to time, changes may be made to these Rules and Guidelines too, for example, reflect changes in our legal or regulatory obligations. Revised versions of these Rules and Guidelines will be posted on this website. Accordingly, we encourage each of our guests to refer back to it on a regular basis prior to attending any event at the Manitoba Stampede & Exhibition grounds.

### 3) REFUND POLICY

- a) There will be no refunds given because of inclement weather. We strive to put on the best show come rain or shine. In the event that the entire event has to be cancelled or postponed because of inclement weather, or for any other reason, there will be no refunds given
- b) There are no refunds given within seven days of event date
- c) Refunds prior to the seven days will be considered on a case by case basis

- i) All forms of knives/scissors/bladed items
- ii) Firearms/slingshots/ammunition
- iii) Replica firearms/ items that appear to be firearms
- iv) Hand tools/electric tools
- v) Alcohol
- vi) Drugs/drug paraphernalia/illegal substances
- vii) Drones/RC devices
- viii) Skateboards/Segway's/wheelies/shoes with wheels
- ix) Mace/pepper spray/bear spray
- x) Paint/markers
- xi) Fireworks
- xii) Explosives/flammable items/ignition devices
- xiii) Compressed and/or liquid gas/aerosol sprays
- xiv) Corrosive chemicals/flammable substances
- xv) Bicycles/scooters
- xvi) Light emitting devices (lasers)
- xvii) Banners/signs/voice amplification devices
- xviii) Air horns/artificial noisemakers
- xix) Sporting Goods (baseball bats, hockey sticks, golf clubs, bows and arrows)
- xx) Masks
- xxi) Pets /other animals except animals with a Service Dog Identification Card
- xxii) Materials of an extremist/offensive /discriminatory nature
- xxiii) Padlocks/chains/zip ties/handcuffs
- xxiv) Flyers/samples/promotional items/giveaways
- xxv) Glass containers /other containers in which their contents cannot be easily checked
- xxvi) Articles of clothing with offensive language/image
- xxvii) Any item deemed a danger/threat to public safety
- xxviii) Please be advised that selfie sticks are prohibited from all midway rides

## 5) PROHIBITED ACTIVITIES

- a) The following activities are not allowed:
  - i) Acts of demonstration, solicitation, distribution or private sale of materials or event tickets on these premises are prohibited unless pre-authorized in writing by the VAS
  - ii) The distribution of printed or recorded materials of any kind.
  - iii) Photography, videotaping or recording of any kind for commercial purposes.
  - iv) Engaging in any unsafe act that may impede the operation of Manitoba Stampede & Exhibition grounds or any associated venue.
