New Business: Amendments to the Constitution and By-laws of the Valley Agricultural Society

Brian Wiebe made the motion to the following amendment:

The Board of Directors shall consist of no less than nine (9) and no more than fourteen (14) officers. The officers of the society shall be the past president, president, vice president, secretary, finance committee chair, and not fewer than four (4) or more than nine (9) members at large. The directors at large shall be from all facets of the society and shall include one (1) director appointed by the Town of Morris and one (1) appointed by the Rural Municipality of Morris. These two (2) appointees shall, upon receipt of membership fees, be full voting members of the Board of Directors. The past president, president, and vice president shall be exofficio directors.

Seconded by Andy Krahn. Carried

Brian Wiebe made the motion the persons qualified to vote for officers or to be elected as such are those members who have paid their membership fee as required by this Constitution. To be elected to the Board of Directors the individual must have been a member in good standing for a minimum of one (1) year prior to being nominated to the board. Seconded by Lou Ericson. Carried.

It was reported that as the number of directors have increased, the number of directors present at board meetings must be increased from six (6) to eight (8) to meet quorum.
